Data Collected Automatically

Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

1. First and last name, Job Title, Employer Name;
2. Work email address; Work phone number; Work or employer address;
3. Personal email address and Age.

This data may be collected using the following methods: Creating an account; and For people who request information from us by opting in to access our materials.

How We Use Personal Data

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for the following purposes:

1. Information and Statistics; and
2. Contact information of users.

The data we collect may be used for communication purposes.

Who We Share Personal Data With

Other Disclosures

4. In the event we seek to sell the company, to buyers or potential buyers who are incorporated in the US, the EU, Canada, UK, Switzerland, Norway, Australia and Japan.

How Long We Store Personal Data
